

ORDINANCE NO. _____

AN ORDINANCE AMENDING CHAPTER 7, "HEALTH AND SANITATION", OF THE CODE OF ORDINANCES OF THE CITY OF COLLEGE STATION, TEXAS, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY, AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLLEGE STATION, TEXAS:

PART 1: That Chapter 7, "Health and Sanitation", of the Code of Ordinances of the City of College Station, Texas, be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

PART 2: That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 3: That any person, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punishable by a fine of not less than Twenty-five Dollars (\$25.00) nor more than Two Thousand Dollars (\$2,000.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its date of passage by the City Council, as provided by Section 34 of the Charter of the City of College Station.



EXHIBIT "A"

That Chapter 7, Section 5, is hereby amended by deleting subsection "C" "7(b)" in its entirety and by adding a new subsection "G" to read as follows:

"G. FEES

- (1) The following fees shall be assessed as set forth in this Chapter. These fees may be reviewed periodically by the City Council and set upon current needs.

(a) Food Establishment Permits:

Food Service Permit	\$225.00
Food Service Follow-up Inspections	\$100.00
Plan Review	N/C
Temporary Food Permits	\$ 55.00
Foodhandler Registration	\$ 20.00 - \$25.00
Certified Food Manager Registration	\$ 10.00

(b) On-Site Sewage Facilities Program:

Single Family Dwellings Permits	\$200.00
Commercial/Multi-family Housing	\$400.00
Reinspection Fee	\$ 25.00
Ten Year Renewal Fee	\$ 60.00
Real Estate OSSF Inspections	\$200.00
Expedite Fee for Real Estate Inspection	\$100.00
Valid Complaint Follow-up	\$100.00

(c) Day Care/Foster Care Facilities:

Inspections of Day Care Facilities	\$ 50.00
Inspections of Foster Care Facilities	\$130.00"
